

### October performance & Blue Sky update

Listed Investment Companies and Trusts (LIC/LITs) within the report cumulatively returned 1.84% in October 2019. In comparison, the S&P/ASX 200 Accumulation Index fell 24.9 points or 0.4% over the month. The majority of LICs with a large-mid cap domestic mandate outperformed this benchmark. Globally, the MSCI All Country World Total Return Index (in AUD) and S&P 500 Total Return Index (in AUD) returned 2.7% and 0.1% respectively. Each of the 3 Asian mandated LICs outperformed the MSCI All Country Asia Ex-Japan Total Return Index (in AUD), which had an October return of 2.4%.


The best performing LIC/LIT in the report during October was **Blue Sky Alternatives Access Fund Limited (BAF)**, returning 10.3%. During the month BAF announced the settlement of the sale of all the interests in the Atira student accommodation portfolio. The sale occurred at a 17% premium to the carrying value. Post the sale, and using the cash balance of \$22.2m as at 30 September 2019, BAF's pro forma cash balance is approximately \$57.8m. This equates to ~29cps or about a third of the market value of BAF. In addition, BAF has a \$67.2m investment in the Argyle Water Fund (via both direct investment and through the Strategic Australian Agriculture Fund), which is subject to monthly independent reviews. 12 months ago it was reported that Aware Water Pty Ltd had placed an offer to purchase this investment from BAF. Based on the current market value of \$173.4m, the pro forma cash balance together with the investment in the Argyle Water Fund accounts for 72% of the market valuation. The remaining part of the portfolio that includes Private Equity, Real Assets and Private Real Estate could therefore be calculated as trading at a 50% discount to BAF's portfolio valuation. As at the end of September 2019, BAF was trading at pre and post-tax NTA discounts of 30.1% and 28.5% respectively. BAF Directors have also stated that they believe the transfer of the investment management arrangements to a new manager would be in the best interest of shareholders. Wilson Asset Management (International) Pty Ltd (WAMI) has previously expressed interest in taking control of the management of BAF.




Chart 1: 3 Year Pre-Tax Performance v Standard Deviation





Chart 4: 5 Year Historical Premium/Discount Tracker by Market Capitalisation




