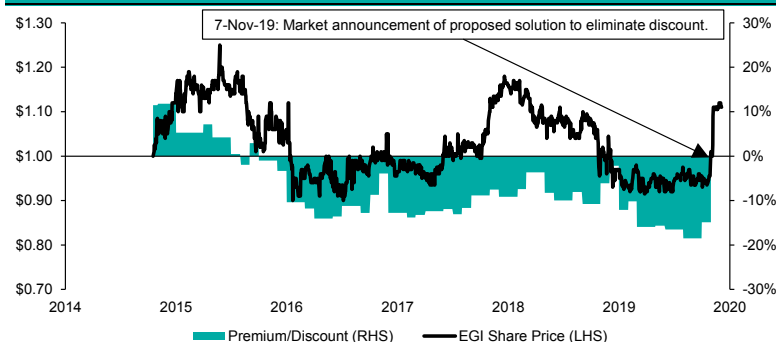

Ellerston Global tops November LIC/LIT returns

The LIC/LITs in the report collectively returned 2.9% (incl. net dividends) in November. The S&P/ASX 200 Accumulation Index and S&P 500 Total Return Index (in AUD) increased 3.3% and 5.5% respectively. Each of the three Asia focused LICs outperformed the benchmark, Asia AC ex-Japan Accumulation Index (in AUD), which returned 2.0%. **PM Capital Asian Opportunities Fund Limited (PAF)** was the top performing Asian LIC with 10.2% and had so far returned 15.1% in Q4, as at the end of November.

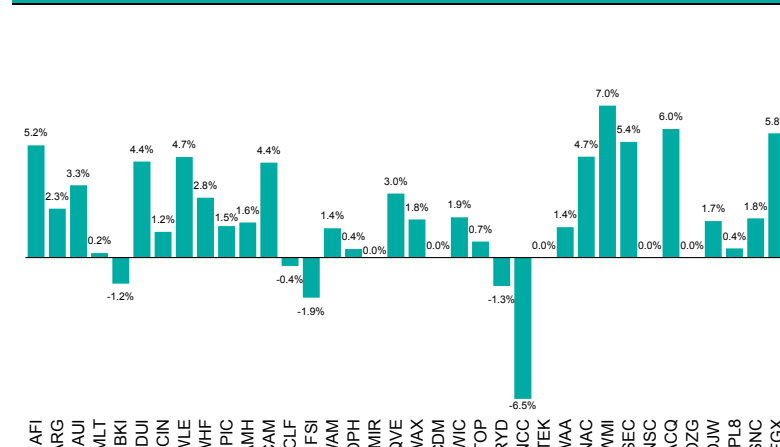
The top performing LIC/LIT was **Ellerston Global Investments Limited (EGI)** which provided shareholders with a 10.9% return. During the month the Board notified shareholders of a strategy to close the persistent discount that the shares have traded at. The proposed solution is to convert EGI from a closed-end LIC to an open-end trust. This would provide unitholders with liquidity at a price that is closer to NTA. The Board has stated that a shareholder meeting to consider the proposal in depth will likely be held in Q1 2020 and they will continue to investigate ASX delivery platforms for open-end trusts. These include both Exchange Traded Managed Funds (commonly referred to as Active ETFs) and mFunds. An approximate completion date at the end of calendar year 2020 was provided by The Board at the AGM, held 29 November 2019.

Figure 1 - EGI daily share price and month-end premium/discount



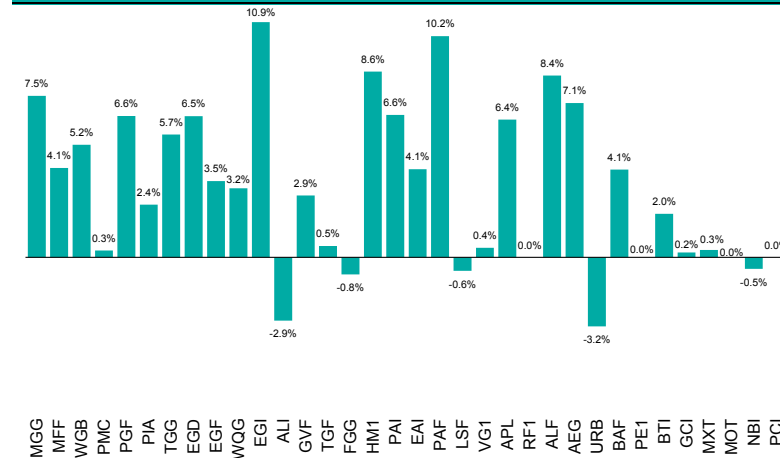

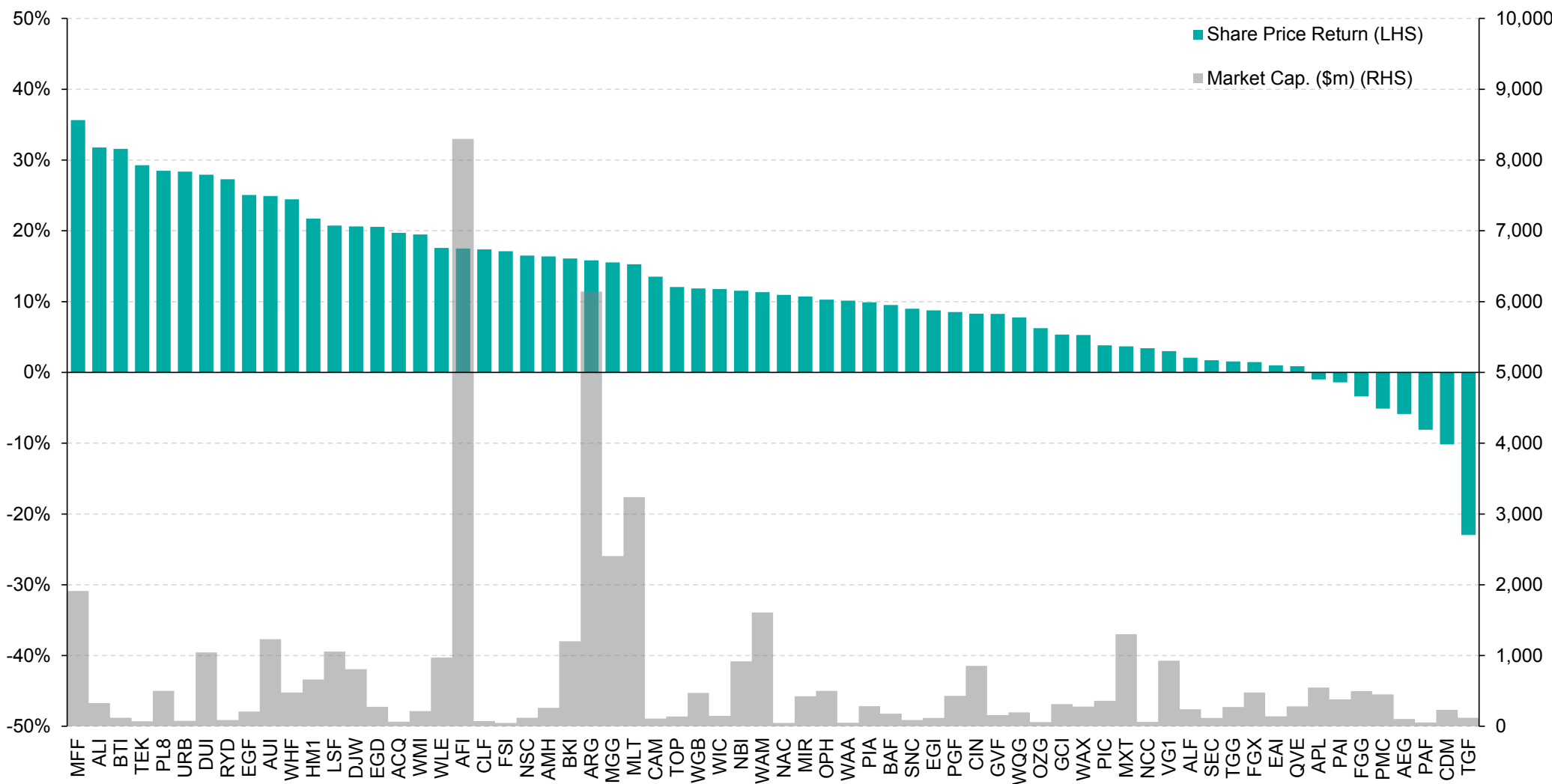
