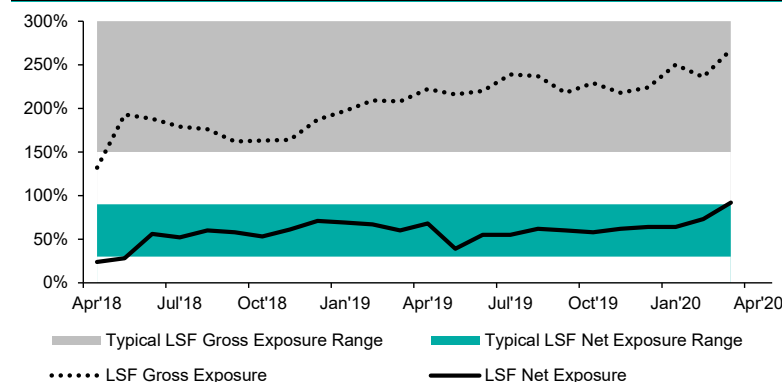

L1 Long Short Fund approaches 2 years on ASX

This month marks two years since **L1 Long Short Fund Ltd (LSF)** raised \$1.3bn in its 2018 IPO. Over this time, LSF shareholders have experienced a negative return of 52.8%. The underlying pre-tax NTA had decreased 36.1% and the discount widened out to 29.6% as at 7 April. LSF's March Investor Report highlighted the net long position in energy

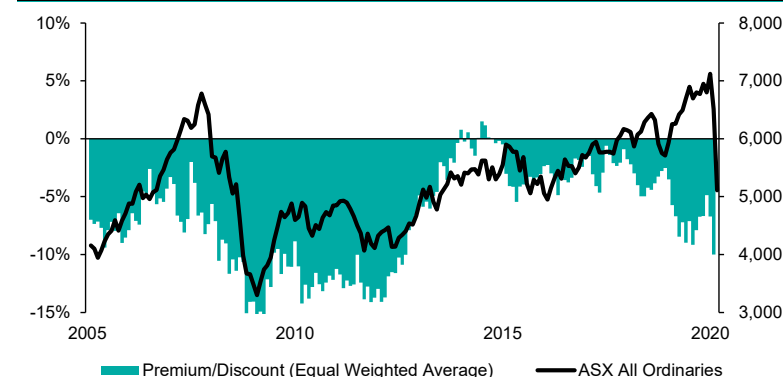
had negatively contributed to the performance of the LIC recently. Net exposure has also been increasing to the upper typical range to be expected, ending March at 92%. This is still below the maximum allowed 150% net exposure. The **VGI Partners Global Investments Ltd (VG1)** portfolio returned 1.4% in March as net exposure decreased from 72% to 45% over the month. The short portfolio, which increased from 19% to 40% over the month, added 2.4% to performance whilst the depreciation of the AUD against the USD offset the majority of the negative performance from the long investments (-5.8%).

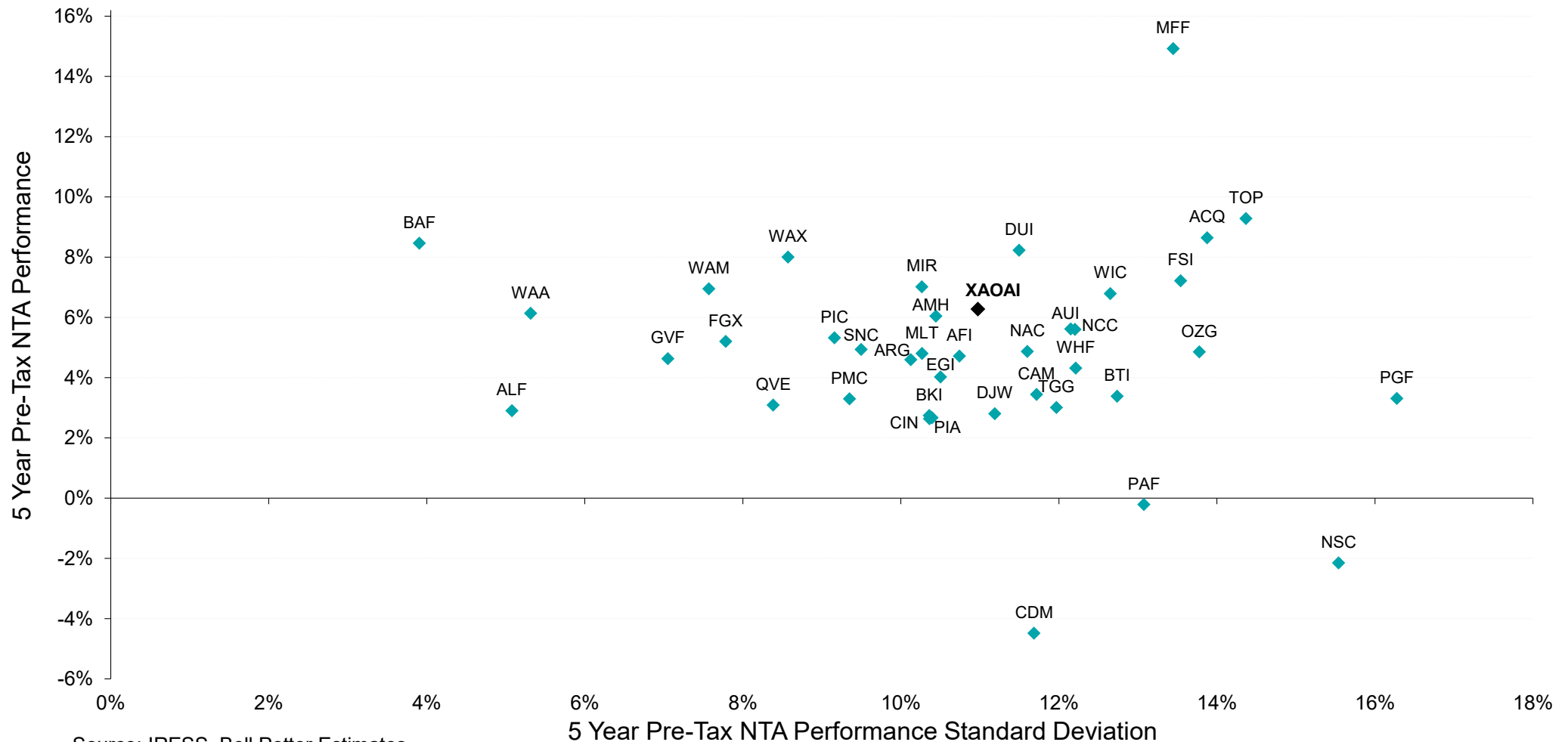
Chart 1: 3 Year Pre-Tax Performance v Standard Deviation

Chart 2: 5 Year Pre-Tax Performance v Standard Deviation

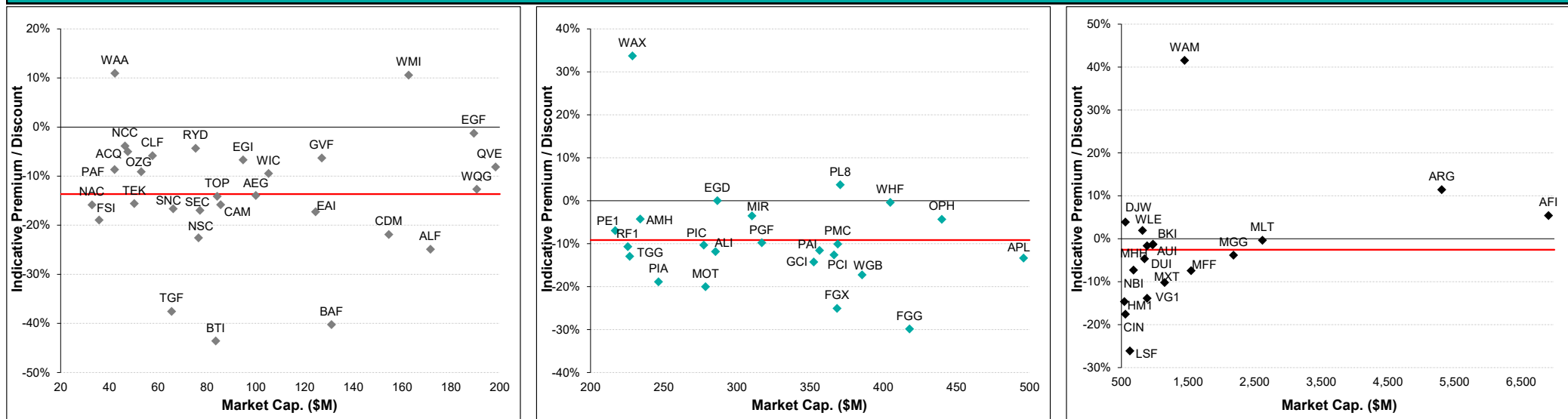

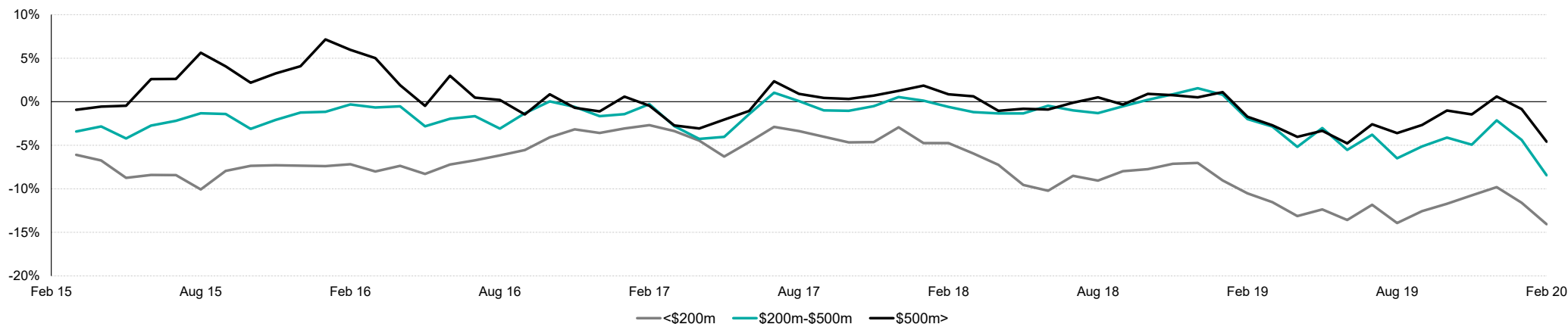


Chart 3: Premium/Discount Relationship Across Market Cap (Equal-Weighted Average Indicated by Red Line)



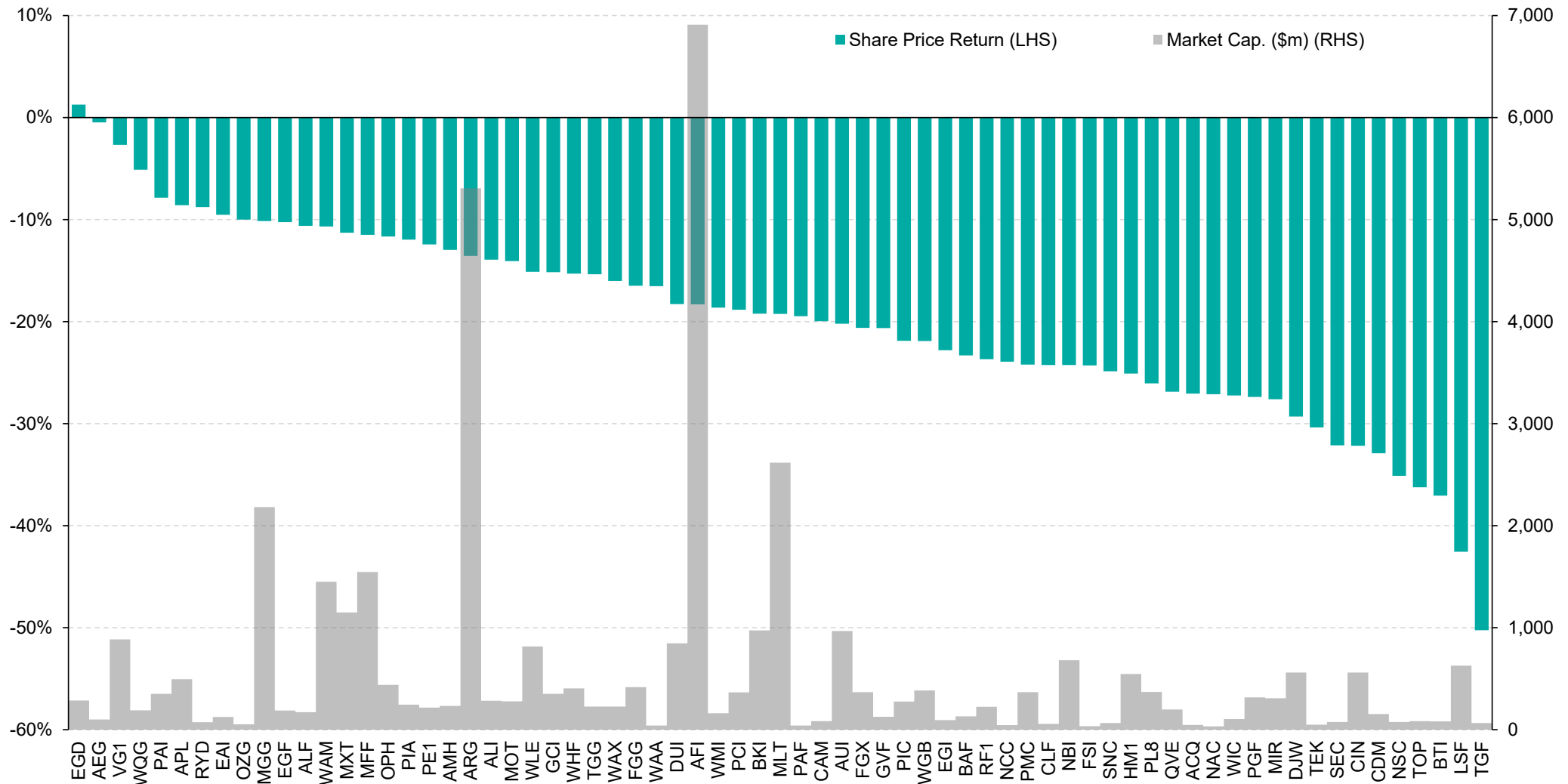
