Fixed interest LITs maintaining income yields

Fixed interest Listed Investment Trusts (LITs) provide investors with the opportunity to gain exposure to a diversified portfolio of a wide range of various income assets. These include domestic and off-shore tradeable and non-tradeable debt securities, Asset Backed Securities (ABS), Residential Mortgage-Backed Securities (RMBS), as well as private loans. Each of the 5 fixed interest LITs in this report aim to pay monthly income distributions, and each has maintained a strong level of income amidst the recent months of volatility.

LITs are closed-end funds that aren't susceptible to large redemptions of units which may negatively impact performance. However, due to this they may experience times when they trade at wide discounts. The average discount to NAV across these LITs is currently ~8.5%. Given that income is generated from the underlying assets and not the unit price, a wider discounts enhances the yield of the LIT that the investor receives. Current indicative premium/discounts and distribution yields for the fixed interest LITs are on pages 3 and 5, respectively, of this report.

Figure 1 - Discounts enhance portfolio distribution yield






Figure 2 - GCI annualised monthly distribution yields (past 6mth)





Figure 3 - MXT annualised monthly distribution yields (past 6mth)





Figure 4 - MOT annualised monthly distribution yields (past 6mth)








Chart 1: 3 Year Pre-Tax Performance v Standard Deviation





Chart 3: Premium/Discount Relationship Across Market Cap (Equal-Weighted Average Indicated by Red Line)




