MFF to issue bonus options

Further to a discussion contained in the recent annual report, the Board of **MFF Capital Investments (MFF)** has today announced the progression of a 1:5 pro rata non-renounceable bonus issue of options. The \$2.60 strike options will be issued at nil consideration and are expected to be quoted on the ASX under code "MFFOA". The options can be exercised at any point prior to the expiry date, being 31 October 2022. MFF has approximately 549.6m ordinary shares on issue, with a market capitalisation of \$1.5bn based on the last closing price of \$2.71. If the 109.9m options issued under the prospectus are subsequently exercised, the company will raise approximately \$285.8m.

MFF has a global equity mandate, with the portfolio invested in listed large-cap international companies that exhibit attractive business characteristics at a discount to their assessed intrinsic values. The portfolio is highly transparent and concentrated, with the top 20 disclosed holdings accounting for ~98% of the portfolio as at 31 July. Notable portfolio weights at this time included Visa (17.9%), MasterCard (16.5%), USD net cash (36.7%) and AUD net cash (4.7%). MFF flagged the bonus issue as multi-faceted, allowing the company to continually fund capital growth and provide shareholders with greater liquidity. MFF has a reputable and proven track record, delivering a share price return of 18.7% p.a. over the past 10 years (incl. net dividends). The \$2.60 strike represents a discount of 4.1% to the last closing share price (\$2.71) and 5.1% to the 31 July pre-tax NTA (\$2.74).

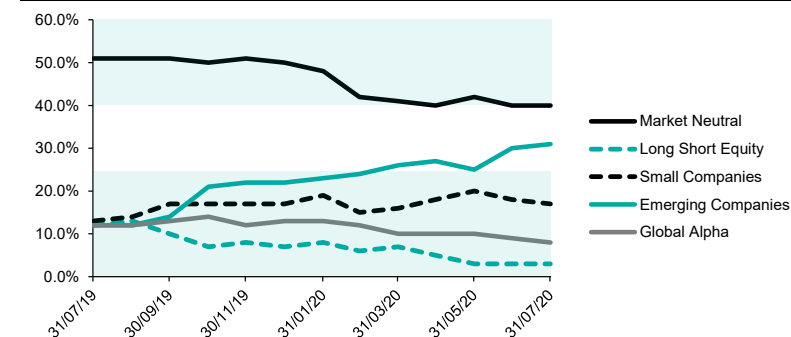

Regal reshapes investment guidelines

Regal Investment Fund (RF1) has announced a change in its investment guidelines. The portfolio is constructed using 5 alternative investment strategies managed by Regal. This includes Market Neutral, Long Short Equity, Small Companies, Emerging Companies and Global Alpha. Measured at the time of investment, RF1's current investment guidelines require a band of exposure between 40-60% of NAV to the Market Neutral Strategy. Exposure to each of the remaining 4 strategies must be maintained within a range of 0-25% of RF1's NAV. The revised guidelines would see the Market Neutral Strategy drop to 0-50% of NAV. Regal has noted the allocative constraints this placed on the investment portfolio. The heavy exposure required by the Market Neutral Strategy, in conjunction with the recent strong performance figures of the Emerging Companies Strategy, has inhibited RF1's ability to efficiently distribute capital. Exposure to the Emerging Companies Strategy is achieved via an investment in the Regal Emerging Companies Fund III. This is an investment vehicle seeking to capitalise on an advantageous gap in the Australian equities market, funding microcaps, unlisted and other pre-IPOs that do not fit mandates of traditional investment firms. There is no ability to redeem for the next 4 years and RF1's investment in the Regal Emerging Companies Fund III has increased 93.8% since inception - now representing 31% of NAV. We see this as a positive, more flexible shift.

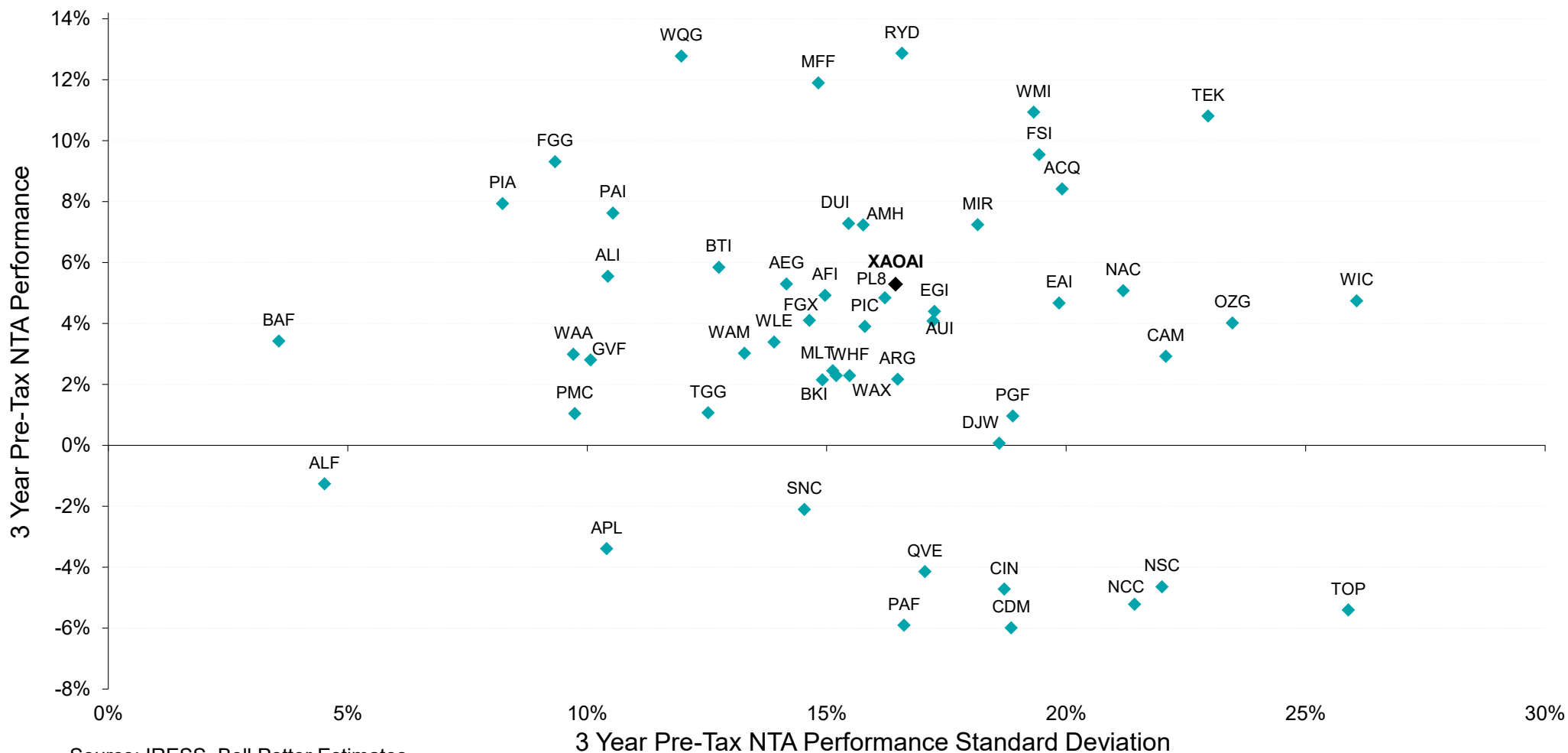

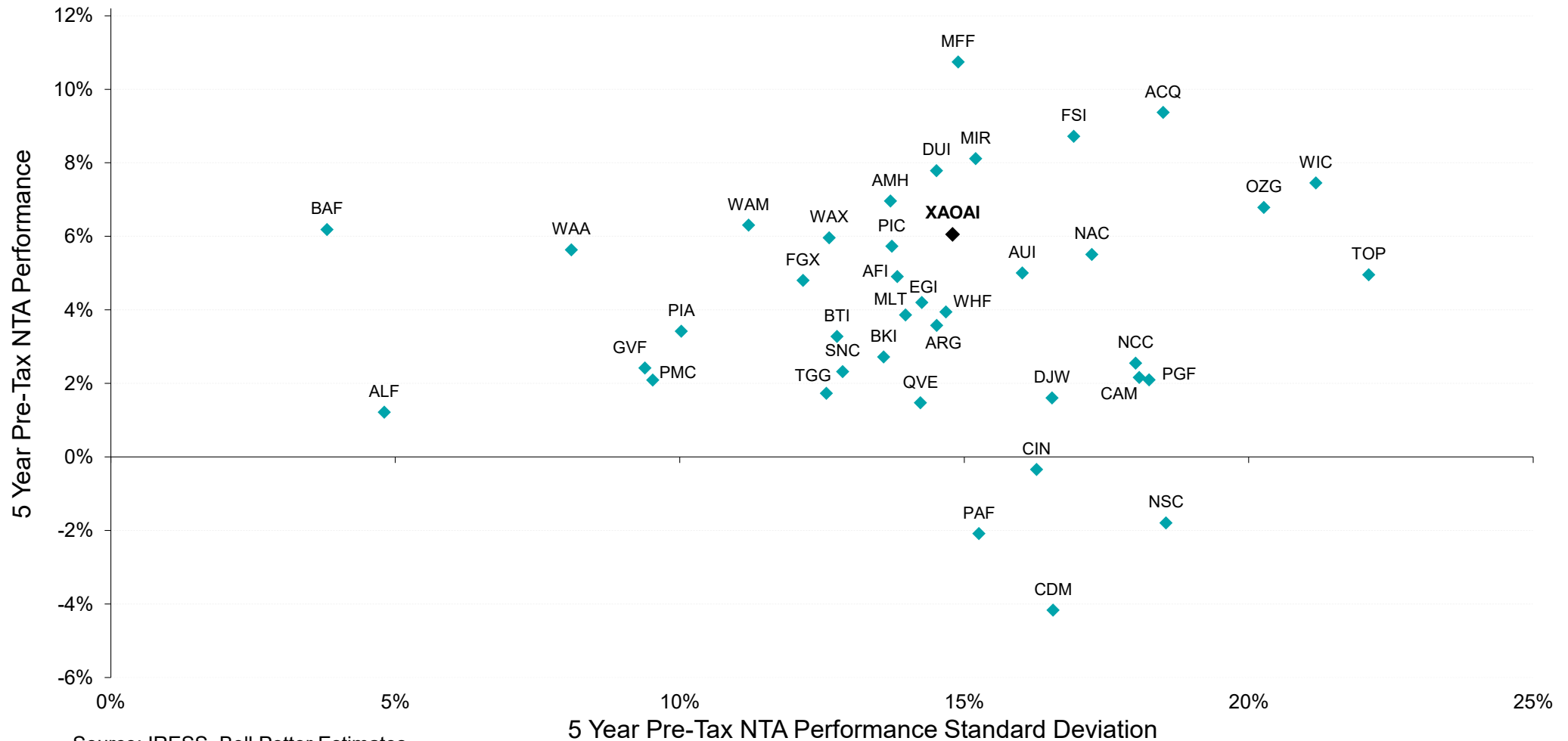
Chart 1: 3 Year Pre-Tax Performance v Standard Deviation

Chart 2: 5 Year Pre-Tax Performance v Standard Deviation

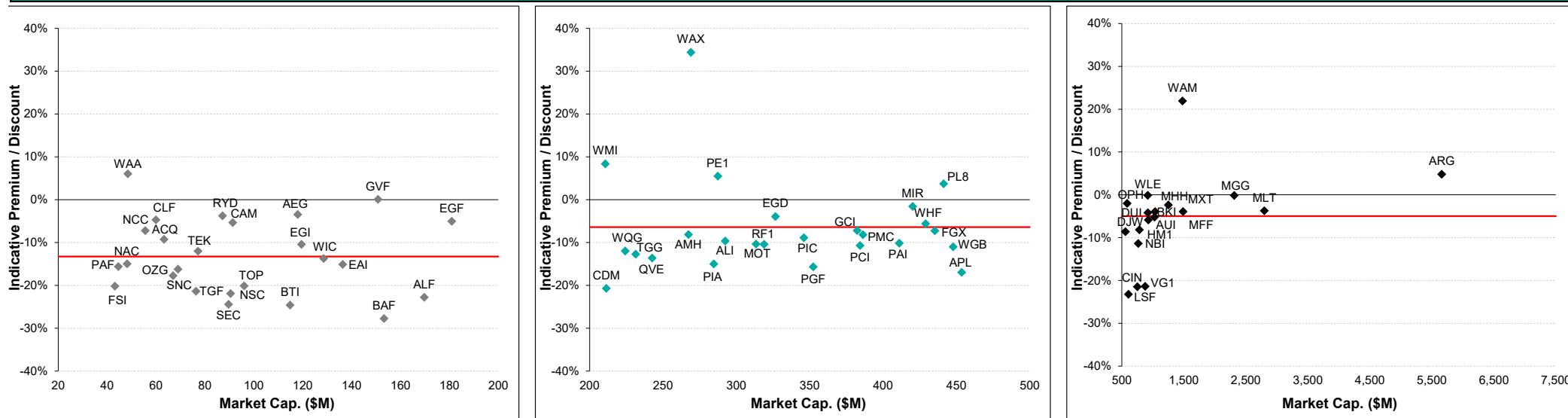

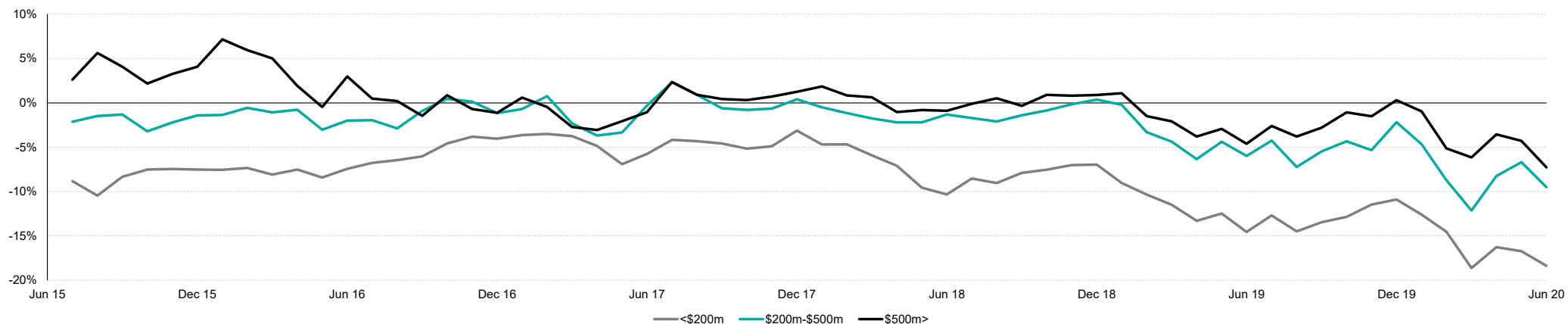


Chart 3: Premium/Discount Relationship Across Market Cap (Equal-Weighted Average Indicated by Red Line)



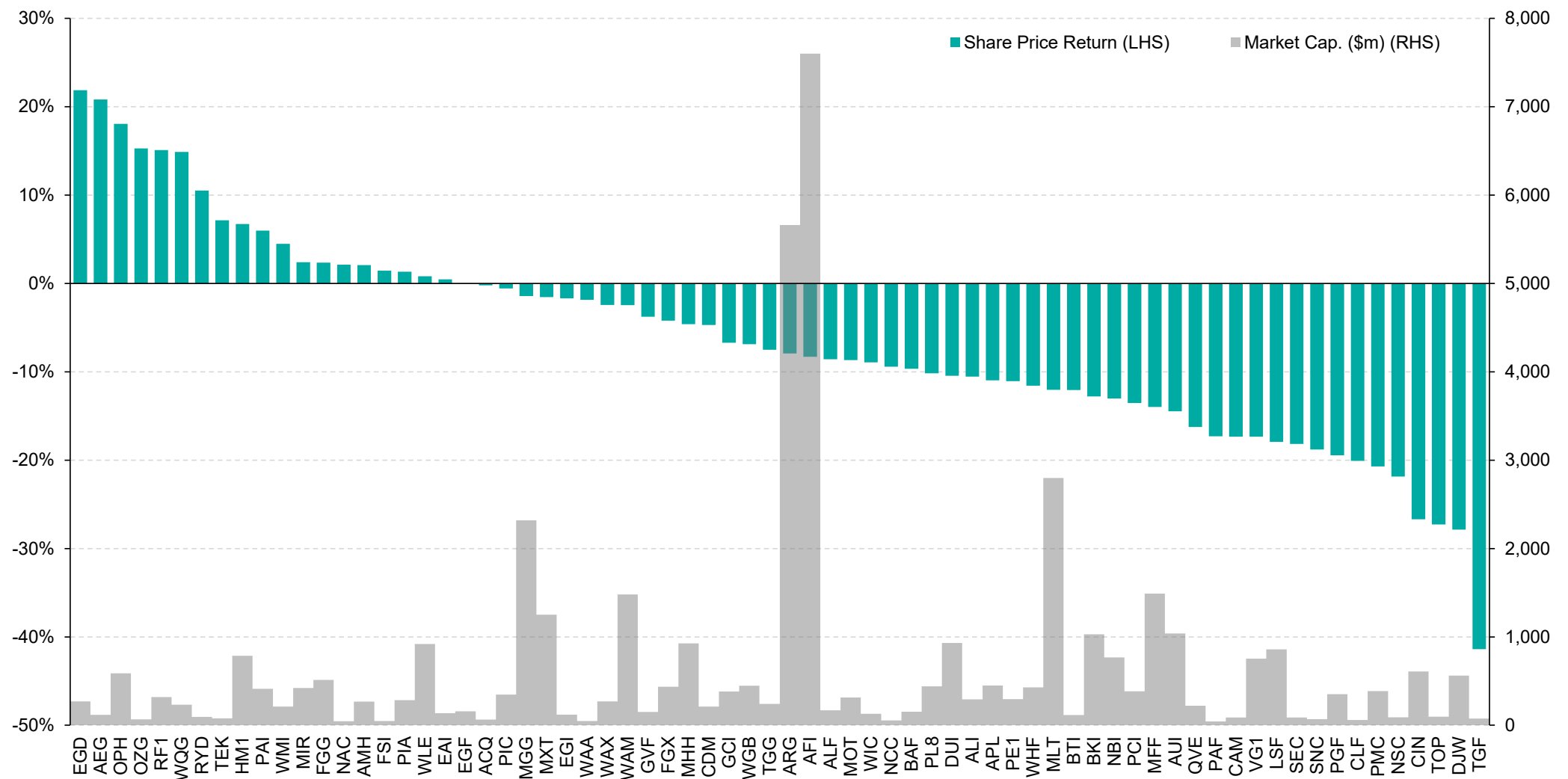
