Sohn Hearts and Minds Investment Conference

The prestigious annual Sohn Hearts and Minds Conference was held virtually on Friday 13 November 2020. The event invites industry heavyweights, global thought leaders, fund managers, CIOs and CEOs in an effort to pitch investment ideas while raising money for Australian medical research. While past performance is no guarantee of future performance, Cathie Wood, Nick Griffin and Beeneet Kothari all returned with high conviction picks on potential rockets for the next 12 months.

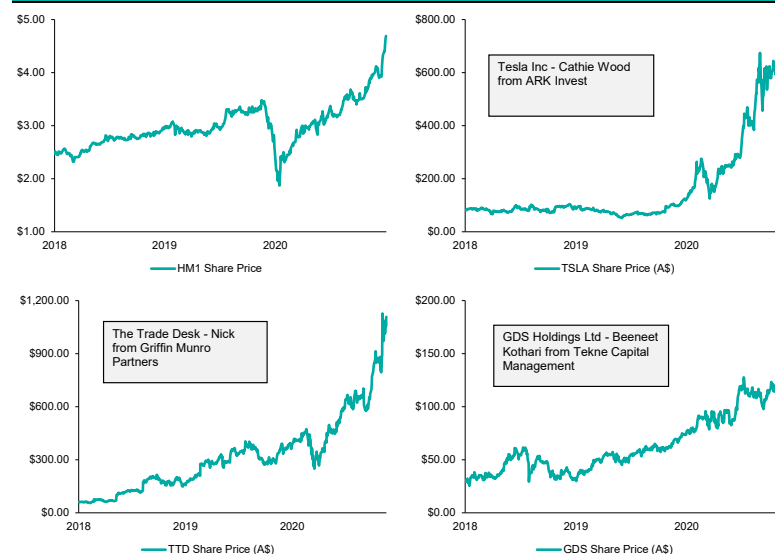
In line with its investment strategy, **Hearts and Minds Investments (HM1)** will be refreshing the conference portfolio (which accounts for 35% of the total investment portfolio) over the coming weeks. The Company will allocate an equal weight to each of the recommendations outlined below in figure 1. This typically includes 10-15 stocks capped at a maximum holding period of 12 months. HM1 forgoes management and performance fees, instead donating to designated charities every six months. Each donation amount is equal to 1.5% (plus GST) p.a. of the average monthly NTA for the previous half-year. Despite a tumultuous calendar year, HM1 has provided a total shareholder return of 31.2% over the last 12 months. We also calculate a sharpe ratio of 0.7 and 1.47 for the share price and pre-tax NTA respectively over this same time.

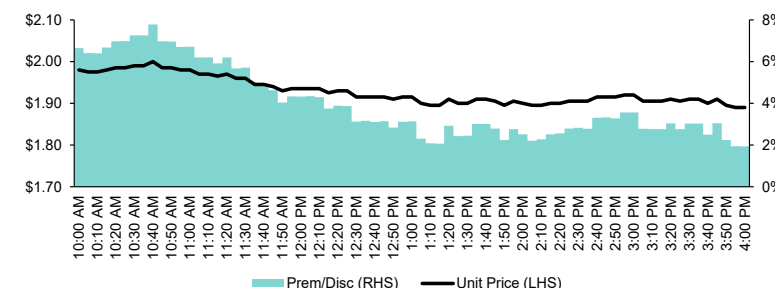
Figure 2 - HM1 and Major 2019/2020 Conference Portfolio Picks

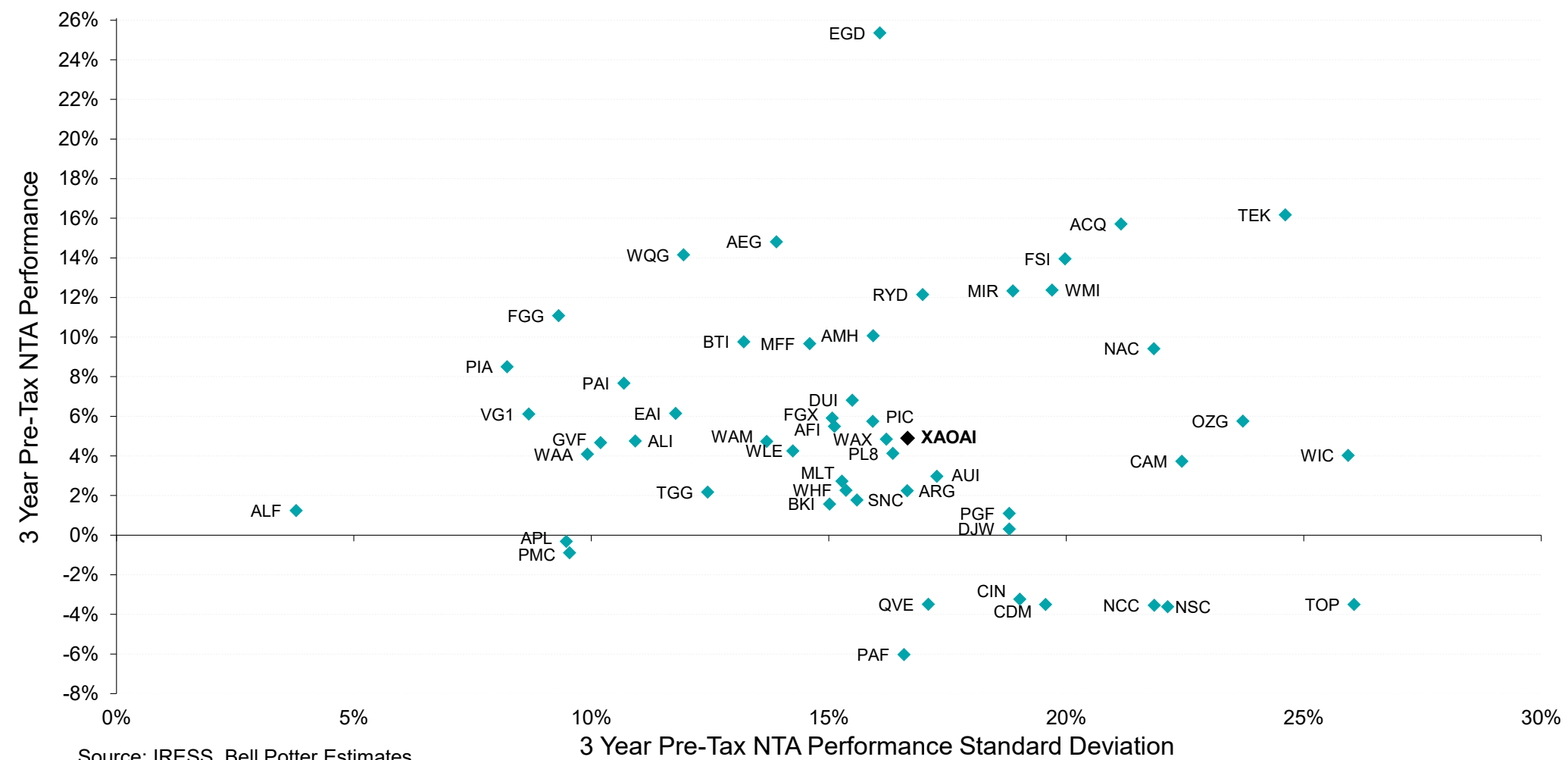

Chart 1: 3 Year Pre-Tax Performance v Standard Deviation

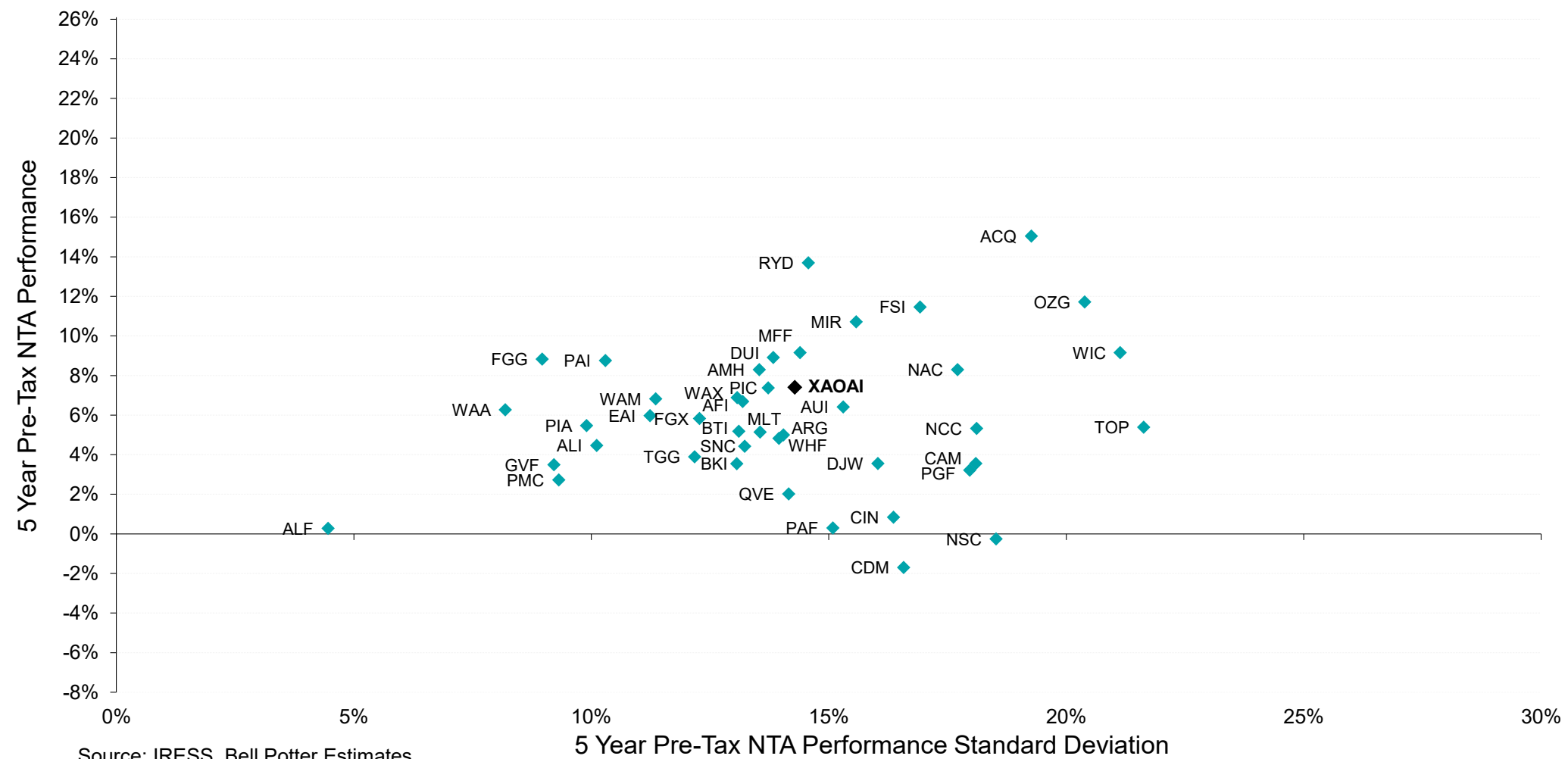

Chart 2: 5 Year Pre-Tax Performance v Standard Deviation

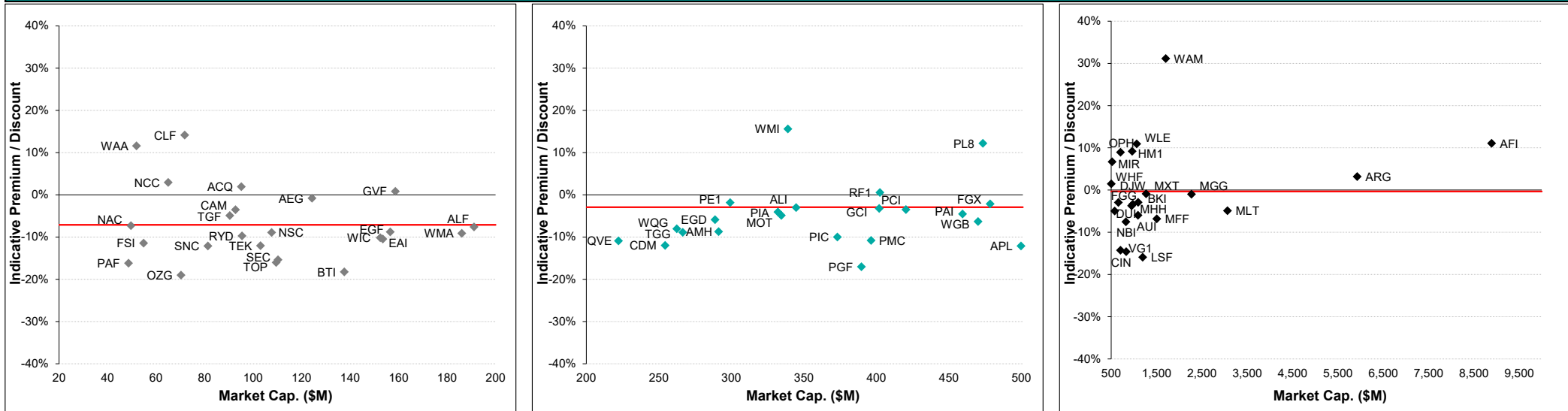

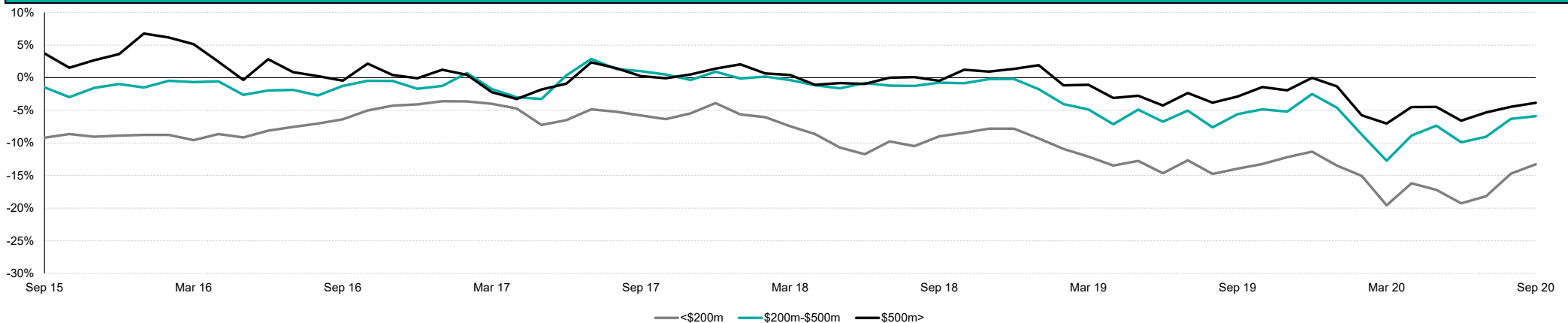

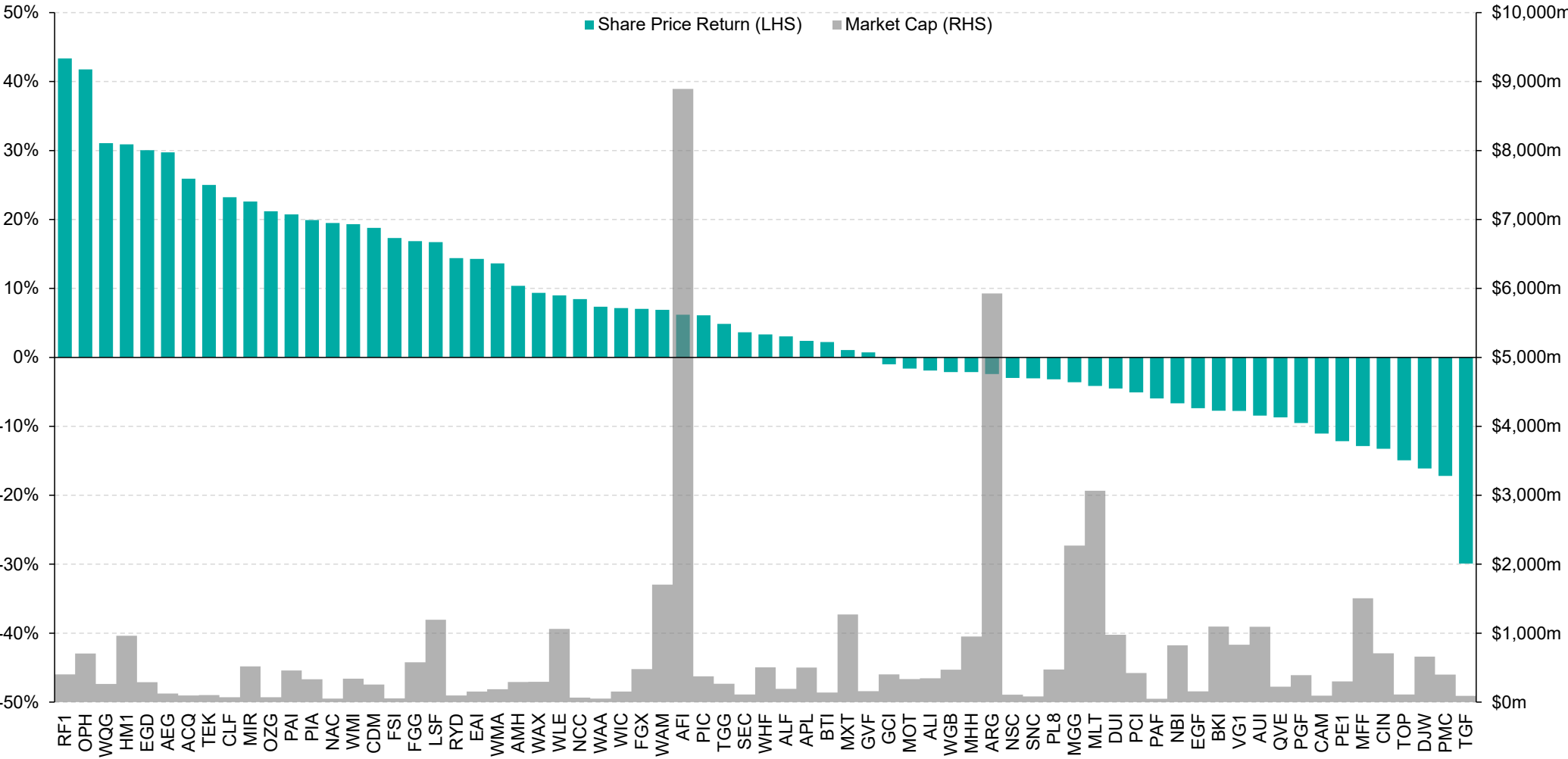
Chart 4: 5 Year Historical Premium/Discount Tracker by Market Capitalisation
